Revenue collection of FY-1398 is till 24th of Hamal, while the collection for FY-1397 is up to end month of Hamal.

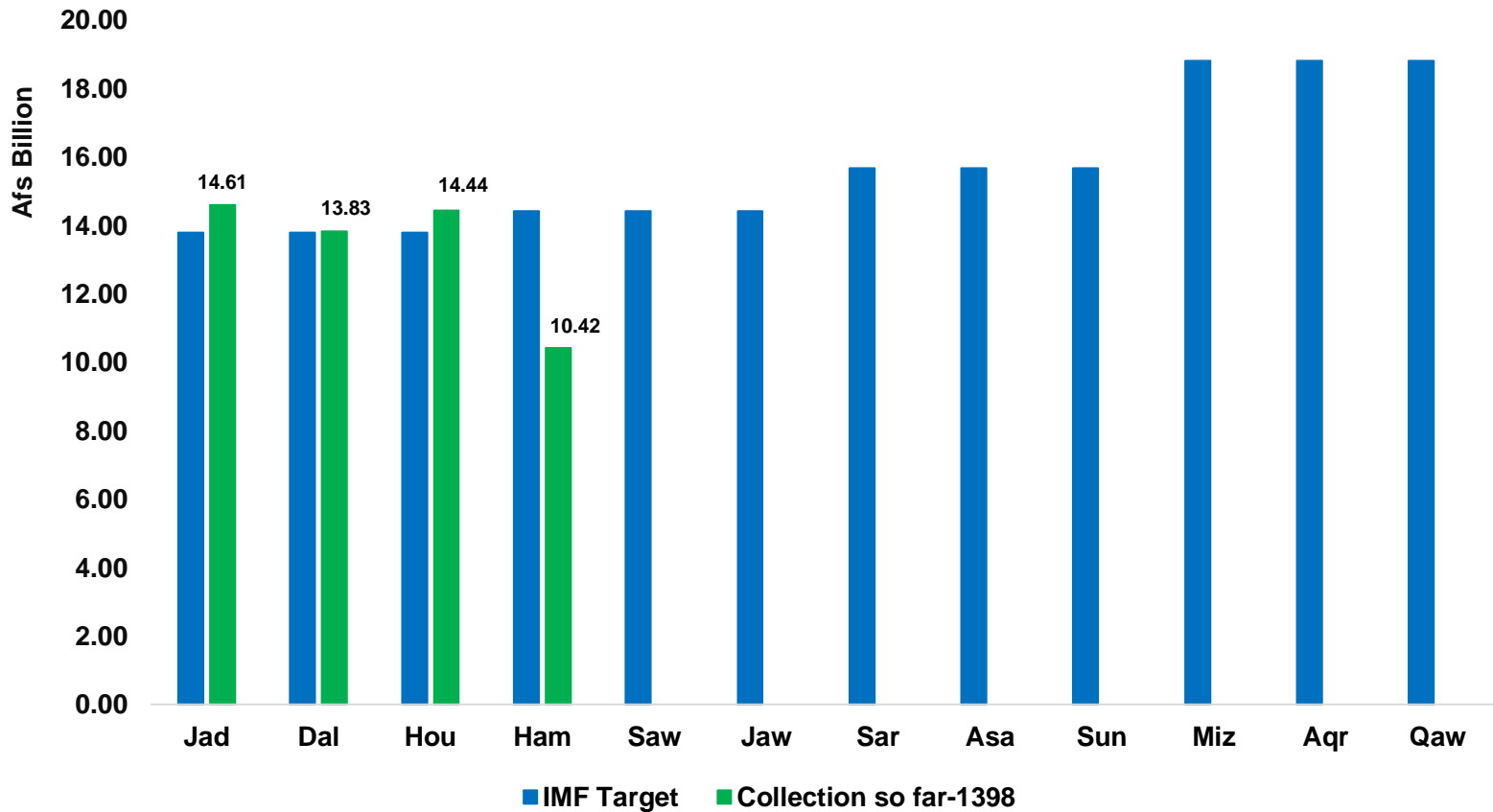

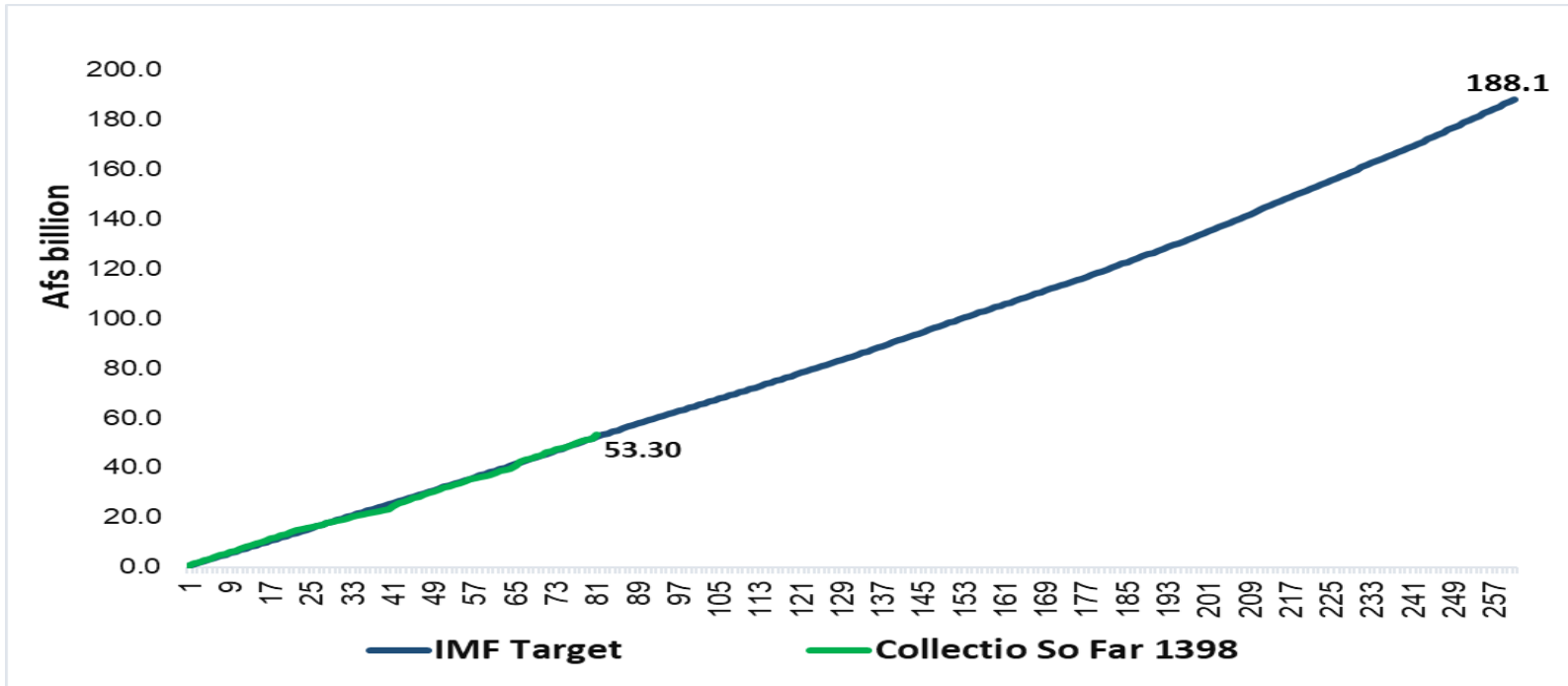
