The following main questions were raised by the applicants and were responded by MoF/MoPH team( Mr.Jawid Yosufzai, Mr. Mohammad Abu Rashed,

Mohammad Jawid Yosufzai & Mohammad Abu Rashed Mr. Hassan Haidar. Dr. Sohrab, and Mr. Matin Zahid)

**Q1:** One of the applicants asked a question regarding Financial Audit Report that could they provide the Financial Status Report, issued by Revenue Department of Ministry of Finance, instead the Financial Audit Report?

**A1:** We know that all the companies submiting their Financial Status Report to the MoF Revenue Departement for the tax clearfication. Regarding this issue we will see a copy of the said Report/certificate whether the mentioned report meets all the requirement of the Evaluation criteria or not, and will notify all the Appliants in writing. There could be few other alternative to an Audit report submission. MoF will discuss such options with appropriate authority and will notify, if adopted, to the Applicants through the relevant procedure as provided in the RFQ.

**Q2:** What about the Contract duration period why this period is for 10 - 12 of the project?

**A2:** The feasibility study of the project affirms that the project is feasible both for the public and private partners. And all related financial issues have been considered in the feasibility study of this project. However, the Contract can be extendable, but will be subject to mutual agreement.

**Q3**: Is it possible that each radiological modality be given a separate contract to a separate entity, for example, CT Scan to one contractor and MRI to another Contractor?

A3: Unfortunately no, but you can make a consortium for this project.

**Q4:** Is it possible for you to provide us a feasibility study for this project?
