## **Introduction**

Lack of expenditure controls not only undermine trust in a government's efforts in managing the public resources, it can also pose risk to fiscal discipline and macroeconomic stability. This report sets out the Government's measures and expenditure allocations for fighting against the Coronavirus. Through this report, the Ministry of Finance aims to honor its commitment of ensuring fiscal transparency and accountability in using public resources. It specifically tracks the expenditures made by different responsible entities in social and health sectors in the context of COVID-19.

## **Country Context**

Since the first case of the Coronavirus was registered in the country, a total of 40,141 confirmed cases infected, and 1,488 confirmed deaths are reported as of 18<sup>th</sup> October, 2020.<sup>1</sup> The coronavirus testing in Afghanistan has been one of the lowest in the world. The MoPH considered large inflow of returnees with exposure to coronavirus as the main risk that affected the speed of the spread of the virus. The Government quickly recognized the seriousness of the COVID-19 pandemic and mapped the likely trajectory of the pandemic into five phases (acknowledgement, diffusion, adversity, relief, and recovery).

The economy of Afghanistan is severely impacted by the spread of COVID-19 pandemic. Major disruptions in domestic activities, regional trade, and the flow of remittances caused a significant contraction in the economy. The real GDP growth was expected to be 3.9 percent pre-COVID-19, but with the wider spread of the virus, the real GDP growth is estimated to slump to a negative territory of 5 percent, which is mainly driven by decline in service and industry sectors, caused by lockdowns in the major cities.

## **Potential Sources for Financing COVID-19 Related Expenditure**

Given the gravity of the pandemic, fiscal response in terms of quick implementation of the required health services would have not been adequate without external support. Due to debt

sustainability considerations, the Ministry of Finance explored grant financing options. The government of Afghanistan, in cooperation with the World Bank and the Asian Development Bank, prepared a relief and mitigation package through reallocating and mobilizing new grants. The government also considered the IMF for accessing interest-free financing available to Low Income Countries.. In addition to the \$220 million disbursement under the RCF (see below), Afghanistan plans to draw on IMF financing under the prospective Extended Credit Facility which will be considered by the IMF Executive Board in early November.

To tackle the pandemic, the government of Afghanistan received grants from International partners including Afs 3.1 billion from the ADB, and Afs 7.7 billion from the World Bank for Emergency Response to COVID-19 and Health System Preparedness Project in 34 provinces (See in annex table 6) and also Afs 23.1 billion for the REACH Program, and an amount of Afs 4.1 billion grant is under discussion with the EU.

### *COVID-19 Relief Effort for Afghan Communities and Households (REACH)*

The World Bank approved a financial package of Afs 23.1 billion (\$ 300 million)<sup>2</sup> for the COVID-19 Relief Effort for Afghan Communities and Households (REACH) Program. The total grant amount is comprised of \$175 million from IDA—the World Bank Group’s fund for the poorest countries—and will be complemented by \$125 million from the Afghanistan Reconstruction Trust Fund (ARTF), managed by the World Bank on behalf of 34 donors. The aim of this program is to provide emergency support to the vulnerable citizens and households in places hardly hit by the the COVID-19 pandemic. The project will benefit about 2.9 million households across Afghanistan.

The REACH project will complement a parallel relief effort organized under the Citizens’ Charter Afghanistan Project. Together, both will cover 90 percent of households in the country under the government’s “Dastarkhan-e-Milli” program, benefitting an estimated 4.1 million households with incomes of \$2 a day or less. The program will be implemented through the Ministry of Rural Rehabilitation and Development (MRRD), the Independent Directorate for Local Governance

(IDLG), and the Kabul Municipality. It will help provide relief to Afghan households through Community Development Councils (CDCs) to purchase food and sanitation packages for households in their respective communities.

### *Rapid Credit Facility (RCF)*

To support Afghanistan’s response to the pandemic, the IMF approved a US\$220 million disbursement under the Rapid Credit Facility in April. The RCF financing is an interest-free loan available to low income countries (LIC) facing an urgent balance of payments needs. Rapid Credit Facility financing is available to low income countries without conditionality. The disbursement, which was drawn in June, helped in meeting the urgent fiscal and balance of payments needs stemming from the COVID-19 pandemic.<sup>3</sup>

## Country Fiscal and Budgetary Responses to COVID-19

### *Immediate Consideration*

The Ministry of Finance prepared the national budget for the fiscal year 2020 by maintaining all the reforms introduced in the fiscal year 2018. Total budget for the fiscal year 2020 pre-COVID-19 was initially estimated at Afs 428 billion, but with the spread of the virus, the national budget experienced two amendments. In the first amendment, the government re-allocated the budget from other sectors to the health and social sectors. Whereas, in the second amendment, Afs 15.9 billion were allocated that prioritized the COVID-19 emergency response in the center and

provinces including construction and renovation of hospitals, medical equipment's, and salary payments of COVID-19 personnel.

Budget in the mid-year review (MYR) also faced substantial adjustment in expenditures. Both operating and development budget expenditures were increased by Afs 9.5 billion during the MYR. Operating expenditures adjusted from Afs 289.1 billion to Afs 298.2 billion, and development budget expenditures adjusted from Afs 139 billion to Afs 155.6 billion.

### *Contingency Appropriations*

Despite the urgent nature of the demand for financing, the Government did its best to use the available resources judiciously and transparently. Clear prioritization of demands on contingency provisions were made to ensure that funds are available to meet high priority needs.

### *Expenditure Reprioritization through Reallocations and Transfers*

Given the additional need to support health and essential services during the outbreak, the Budget Directorate estimated resource requirements for emergency response and identified low priority spending that could be reduced to generate saving and create room for priority spending. Projects and programs with low priority or weak performance in the operating budget were deducted by Afs 3.2 billion and Afs 2.1 billion in development budget including contingencies. See in annex tables 7 and 8 for the detailed list of these projects and programs.

### *Budget allocation for COVID-19*

Since the spread of the COVID-19 virus in the country, the government allocated a sum of Afs 19.8 billion, from which Afs 9.6 billion was previously allocated and the remaining Afs 10.2 billion is approved by the Parliament in the second budget amendment. The allocation of the budget has been prioritized for the necessary projects and areas. An amount of Afs 2.4 billion has been reallocated and transferred to provinces to fight against COVID-19. Afs 1.41 billion which was previously allocated to the reconstruction and renovation of the Darulaman Palace has been redirected to the construction of 50 bed hospitals in Herat, Farah, Nimroz and Kabul provinces. From the operating budget of the Ministry of Agriculture and Livestock, Afs 1.7 billion has been redirected to purchase wheat. Also, based on the instruction of the President, Afs 1.15 billion has

been reallocated to the Ministry of Public Health to use it against COVID-19 in center and provinces. Afs 77 million has been reoriented to strategic and communication directorate at President Office to raise public awareness about the Virus. Afs 2.8 billion has been transferred to start bread distribution program in Kabul and provinces.

The Coronavirus also caused second amendment in the national budget. COVID-19 negatively impacted a significant part of trade and economic activity, this also caused a substantial reduction in the export of agriculture commodities through air corridors. Resultantly, Afghanistan's trade balance has further deteriorated. To address this concern and prevent further reduction in the export of agriculture commodities, Afs 5.8 billion has been reallocated as a result of the second amendment in the national budget to initiate a management program for agriculture commodities. For the purchase of equipment, procurement, enhancing the quality of health service and the construction of hospitals and clinics, an amount of Afs 3.4 billion has been given to the Ministry of Public Health, and Afs one billion has been allocated to the Ministry of Energy and Water for water management project.

## COVID-19 Related Expenditures

To fight against the COVID-19 pandemic, total allocated budget is Afs 30.7 billion, of which the government of Afghanistan has contributed Afs 19.8 billion and the remaining budget comes

from donor partners. From the total budget allocation, Afs 3.8 billion allocated to the operating budget and Afs 2.1 billion to the development budget. Afs 13.9 billion was allocated to build COVID-19 specialized hospitals, beds and rainwater control system which is implement by the National Development Corporation (NDC). In addition, Afs 14 billion was allocated to Kabul Municipality for purchasing sanitizing equipment and advertisements to raise awareness about Coronavirus.

From the operating budget, Afs 1.9 billion is spent till the third quarter of the year containing mostly salaries paid for the COVID-19 personnel and purchases of necessary equipment to tackle against the virus; of which Afs 426.1 million is spent in the third quarter alone. The development budget expenditure amounted Afs 1.1 billion of which Afs 474.6 million is spent in the third quarter of the fiscal year. These amounts were spent mostly on purchasing medical equipment, medicines and salary payments to the COVID-19 employees.

The World Bank also have provided Afs 7.7 billion for the COVID-19 emergency response and health care systems project which is implemented through NGOs. Out of this amount, Afs 2.2 billion is spent till end of the third quarter. Afs 154 million has been spent in the third quarter. *(See annex table 6 for detailed report)*. The Asian Development Bank and Global Fund budget for COVID-19 is Afs 3.1 billion and Afs 13.1 million, respectively. Afs 9.3 million is spent from the Global Fund budget whereas, the ADB budget has not been spent yet.

Total remaining budget allocated by the government and donors to COVID-19 pandemic amounts to 25.1 billion. This whole amount will be spent on measures to tackle the Coronavirus. The NDC contracts are long term and the payments are scheduled to be paid on its completion. The World Bank emergency response project in all provinces has a lifecycle of 4 years and the contract amounts are expected to be paid during the project period.

### *Expenditures by the Ministry of Public Health*

Table 2 provides detailed report of the development and operating expenditures occurred under COVID-19 by the MoPH in Kabul. Total operating expenditures were Afs 958.6 million and development expenditures were Afs 63.1 million. The operating expenditure mainly cover the necessary purchases and salary payments for the hospitals specialized for COVID-19 in Kabul. The development expenditure paid through the central ministry, includes salaries payments to the COVID-19 employees.

*Expenditures by National Development Corporation (NDC)*

The National Development Corporation has implemented four projects designed for coping with COVID-19 which include rainwater control system project, construction of 100-bed hospitals in 5 provinces and 50-bed hospitals in 5 districts and also purchase of beds for COVID-19 patients. The total amount of these projects amounts to Afs 13.9 billion of which only Afs 375.2 million is paid so far and the remaining amount is under procurement process which will be paid upon completion of the project.
